

- 12. The Personal Contact programs will be conducted in the Study Centres normally from Sep/ Oct to Mar/ Apr (Seven months).
- 13. Any dispute arising with regard to any aspect of this undertaking, the concerned parties will resolved the same amicably. However, in case the dispute remains unresolved, it shall be referred to an Arbitrator, to be appointed by mutual consent of both the parties subject to Delhi jurisdiction. The decision of the Arbitrator shall be final and binding upon both the parties concerned.
