# **Timeline**

The acceptance or rejection of the abstract will be communicated by the review committee within 3 days of the receipt of the abstract. The acceptance of full paper will be communicated latest by February 2, 2024.

# **Guidelines for authors**

- **Title page**: The title page of the article must consist of title, author(s) name(s), designation(s), affiliation(s), phone number(s) and email id(s). Also, indicate the name and contact information of the corresponding author.
- **Abstract**: Abstract should not be of more than 200 words and should include the title, objectives, methodology and findings/results.
- **Manuscript Format**: Font type- Times New Roman; Font Size- 12; Spacing- 1.5; Alignment-Justified; Page margin- 2.
- **Figures and Tables**: Please ensure the figures and the tables are placed next to the relevant text in the manuscript, rather than at the bottom or the top of the file. Also, tables should be numbered consecutively in the text in Arabic numerals.
- **Referencing style**: Citations in the text should follow the referencing style used by the American Psychological Association (APA).
- **Originality**: Submitted paper must be the original work of the author(s) and should not have been previously published nor be currently under consideration for publication elsewhere.

# **Review process**

All submissions will be rigorously reviewed by the conference committee. The review process acceptance criteria will focus on originality, presentation quality, technical soundness and relevance to the theme of the conference. The decision of conference committee will be final and binding in all respects.

#### Best paper award

One paper in each technical session will be selected to receive the Best Paper Award. The selection will be made by the panel of experts and their decision will be final and binding.

# **Publication**

Selected papers will be published in a peer-reviewed journal having an ISSN number.
